Livingston County Sheriff's Office Advisory:

The Livingston County Sheriff's Office is investigating a suspicious situation that occurred on August 26, 2017 at approximately 7:00PM in Putnam Township, near the area of M-36 and Cedar Lake Rd. A homeowner reported that her two young children ages 4 and 7 were approached by a suspicious subject in a newer style full-size white cargo van. She reported that a white male subject exited the van and approached the children. The homeowner indicated that after noticing her, the suspicious subject got back into the van and left the area. The homeowner believed that there may have been additional subjects in the van but was not able to provide any further description.

The Livingston County Sheriff's Office is currently working with the Hamburg Township Police Department and Washtenaw County Sheriff's Department on possible similar incidents that occurred over the weekend. It is unknown at this time if the incidents are related.

The subject was described as a white male approximately 30 years of age last seen wearing a white bandana over his hair, a white t-shirt and blue jeans. The vehicle was described a newer white full-size cargo van with rear tinted windows.

Hamburg Township Police Advisory:

The Hamburg Township Police Department is investigating a suspicious situation which occurred on August 26, 2017 in the Hay Creek subdivision near M-36 & McGregor Road in Hamburg Township. At approximately 2:00 pm, a 12-year old boy was approached by a vehicle that he described as a "gray minivan." The driver of the vehicle proceeded to call out to the boy asking him if he would like a ride home. The subject in this incident is described as a white male in his 20's.

The Hamburg Township Police Department is currently working with the Washtenaw County Sheriff's Department and the Livingston County Sheriff's Department to determine if this incident is related to similar incidents that have occurred recently.

At approximately 9:00pm on 08/27/2017, the Washtenaw County Sheriff's Department received a report involving a 9-year old boy who stated that a "white work van" with no decals had approached him and an occupant told him to get into the van. This incident occurred in the area of McGregor Road and Portage Lake Avenue in Dexter Township. The white van was occupied by two white males.

The Livingston County Sheriff's Department also received two similar complaints involving a white cargo van. These two incidents occurred in Putnam Township in the area of Cedar Lake Road & M-36 and Cedar Lake Road & Patterson Lake Road.

Washtenaw County Sheriff's Office Advisory:

The Washtenaw County Sheriff's Office is working in conjunction with the Livingston County Sheriff's Office, as well as Hamburg Township Police Department, regarding three separate attempted child luring incidents which have occurred since Saturday, August 26, 2017.

The Washtenaw County incident occurred in the area of Orchard Street and Portage Lake Avenue in Dexter Township on the evening of August 27, 2017, at approximately 9:00 p.m. A nine year old was riding his bicycle when the driver of a white cargo style van exited the vehicle and told the child to get into the van. At this time, a second individual exited the van from the front passenger door but did not make any statements to the child. The child fled on his bicycle and immediately reported the incident to his mother.

In all three incidents the suspects targeted white male children between the ages of 4 to 12 years of age. The driver of the suspect vehicle is described as a white male, approximately 20 YOA, no facial hair, thin build, black sweatshirt, grey sweatpants, and unknown color of hair. No physical description available of the suspect in the passenger seat.
