**ENFORCEMENT NOTICE**

This letter is to advise you of the commencement of escalated enforcement action against Diamond Chrome Plating, Incorporated for alleged violations that occurred at its facility located in Howell, Michigan related to emissions of trichlorethylene (TCE) from batch vapor degreaser operations and associated recordkeeping and reporting. This letter follows the May 14, 2018; December 20, 2018; September 3, 2019; and October 30, 2019 Violation Notices issued by the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), which detail violations of the National Emission Standards for Hazardous Air Pollutants for Halogenated Solvent Cleaning (Halogenated Solvent Cleaner NESHAP), Title 40 of the Code of Federal Regulations, Part 63, Subpart T; and Rules 201 and 910 of the Michigan Air Pollution Control Rules, Mich Admin Code, R 336.1201 and R 336.1910.

The AQD is providing the Company with an opportunity to formally resolve these violations through the entry of a legally enforceable agreement that will include a compliance program and payment of an appropriate monetary penalty pursuant to Section 5528 of Part 55 of NREPA, MCL 324.5528.

Be advised that failure to respond to this Enforcement Notice in a timely manner and adequately resolve or address the cited violations may result in further enforcement proceedings, including but not limited to, referral of the matter to the Michigan Department of Attorney General (DAG) for commencement of civil litigation. This
