Around May of 2024, Nakagiri, through his federal independent expenditure-only political committee Keep Livingston Great, which he is the treasurer of, mailed out a postcard which, in addition to promoting Donald Trump, also promoted his primary re-election campaign for Livingston county commissioner, putting it in the scope of the MCFA. The mailer in question only includes the name of the committee, and not the address, PO Box 126, Hartland, MI, as required by 169.247(1)

On May 27, 2024, Nakagiri displayed a few banners and an A-frame sign which, again, promoted both Donald Trump, as well as his primary re-election campaign for Livingston county commissioner. Neither the banners nor the A-frame sign included an identification statement on them, as required by 169.247(1). This may also be a violation of federal campaign finance law, however, that is outside the scope of this complaint.

Evidence included with the submission of the complaint that supports the allegations:

I have included a scan of both sides of Nakagiris postcard. While the postcard purports to be in support of Donald Trump, Wes Nakagiris name is mentioned 10 times, while Trumps name is only mentioned 8 times. In addition, Nakagiris campaign logo is on the postcard, which can also be seen on some of his signs (a photo of which is also attached). It also includes a note about him seeking re-election in the August 2024 primary.

In addition, I have included a photo of a banner containing Nakagiris campaign logo, as well as an A-frame referencing Nakagiri. I have also included a photo of the win a free Trump sign sign as well as its identifying statement.

Finally, I have included Keep Livingston Greats June 2024 monthly statement as well as Friends of Wes Nakagiris 2024 primary pre-election statement.

Section 15(8) of the MCFA provides that a person who files a complaint with a false certification is responsible for a civil violation of the MCFA. The person may be required to pay a civil fine of up to \$1,000 and some, or all, of the expenses incurred by the Michigan Department of State and the alleged violator as a direct result of the filing of the complaint. MCL 169.215(16).

The financial disclosure acts prohibit a person from filing a complaint with a false certification. MCL 169.313(7); MCL 15.713(7).

Finally, on August 6, 2024, Nakagiri had signs up saying “Win a FREE Trump Sign, Wes Nakagiri, Trump National Delegate” at the Hartland Township polling place during the primary election, where he was a candidate for Livingston county commissioner, with an appropriate identifying statement for Keep Livingston Great. Due to the timing and location of this sign, I believe this sign also promotes Nakagiri’s campaign.

The purchase and mailing of the above-mentioned postcards, and the purchase of the other above-mentioned displays, constitute an in-kind contribution from the federal Keep Livingston Great committee to Nakagiri’s candidate committee under 169.204(1), as they are not considered an independent expenditure under 169.209(2) due to Nakagiri’s involvement in the expenditure as the treasurer of the committee. This in-kind contribution was not reported in his candidate committee 2024 primary pre-election statement. In addition, 169.224b(4) “An independent expenditure committee shall not make a contribution to a candidate committee...” was violated. Finally, the amount of the in-kind contribution was \$2176.32 according to the June 2024 statement for Keep Livingston Great, which exceeds the contribution limit, as Keep Livingston Great is not an independent committee or a political party committee.

There may be other violations which I have not identified here related to this.

During the Republican Primary in August, Wes will be seeking re-election to his fourth term on the Livingston County Board of Commissioners.

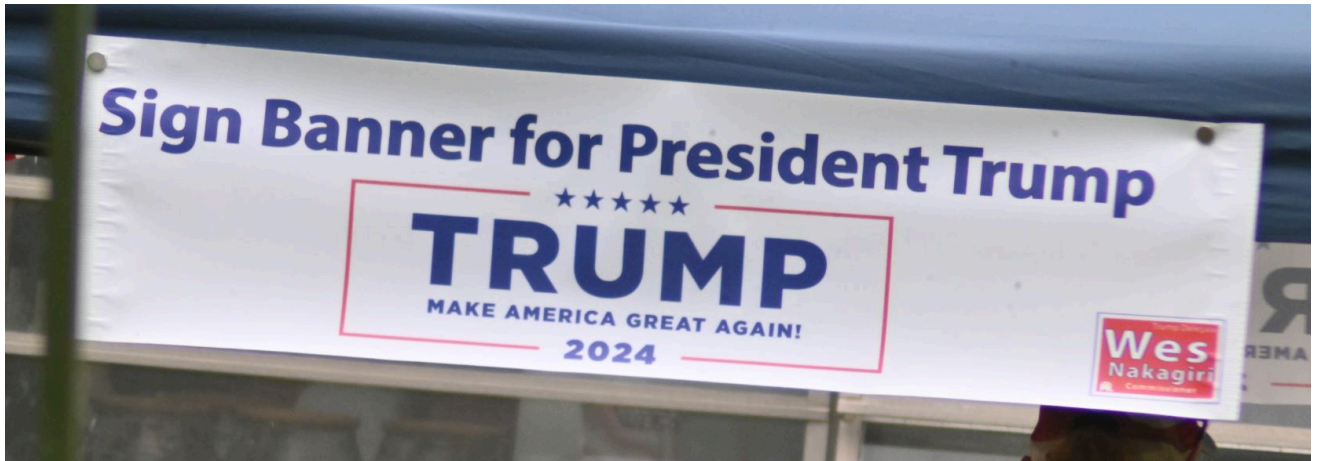

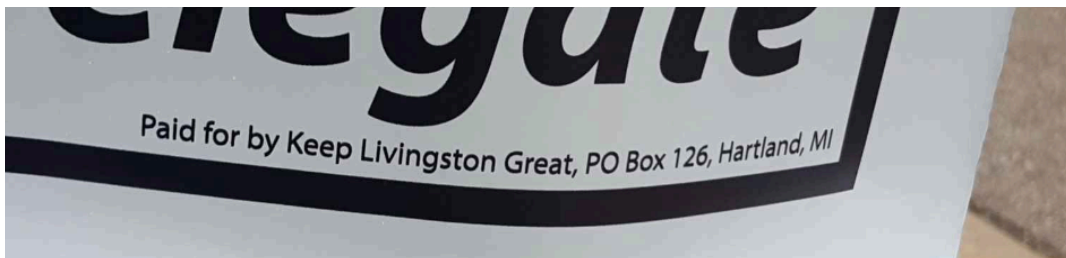

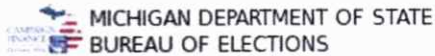
